LIMITED LIFETIME WARRANTY

Wolf Portrait™ Siding (the "Product") is manufactured for Wolf Home Products by Inteplast Group Corporation (the "Manufacturer") and is backed by this limited lifetime warranty from the Manufacturer.

MANUFACTURING AND MATERIAL DEFECTS

RESIDENTIAL PURCHASERS - LIMITED LIFETIME

This 50-year Limited Lifetime Warranty covers the Product installed on a single-family home, townhome, or multifamily dwelling (up to 3 units) that are not owned by corporate entities (e.g. corporations, LLCs), governmental agencies, partnerships, trusts, religious organizations, schools, condominiums or pursuant to cooperative housing arrangements ("Residential Purchasers"). This 50-year limited lifetime warranty is personal to Residential Purchasers; however, it may be transferred to any subsequent purchaser(s) of your home or building during the first five (5) years after the date of the original purchase of the Product.

NON-RESIDENTIAL PURCHASERS - 20 YEARS

This 20-year limited lifetime warranty is given to all original purchasers of the Product, other than Residential Purchasers, who purchase the Product and use it in applications other than those reserved for Residential Purchasers, including uses in commercial buildings, condominiums and multi-family dwellings (a "Non-Residential Purchaser").

LIMITED LIFETIME WARRANTY AGAINST MANUFACTURING AND MATERIAL DEFECTS

If, due solely to manufacturing or material defects, the Product is found during the warranty period to rot, delaminate, splinter, split, excessively swell, or suffer structural damage from termites or fungal decay, the Manufacturer will, at its sole and absolute discretion, provide replacement Product, repair the defective Product, or refund a proportional part of the purchase price of the Product prorated over 50 years to the Residential Purchaser and prorated over 20 years to the Non-Residential Purchaser. This limited warranty shall not cover, and the Manufacturer shall not be responsible for, costs and expenses incurred with respect to the repair or removal of affected Product or the installation of replacement Product, including but not limited to labor, materials and freight. The foregoing remedies are the SOLE AND EXCLUSIVE REMEDIES FOR THE BREACH OF THIS LIMITED WARRANTY.

CLAIM PROCEDURE

In order to make a claim under this limited lifetime warranty against manufacturing and material defects, and before the Manufacturer's obligation under this limited lifetime warranty shall commence, the Residential Purchaser or Non-Residential Purchaser must send proof of purchase, photographs of the defective Product, and a written description giving full particulars within 30 days of discovering a defect believed to be covered by this limited lifetime warranty (and prior to beginning any repair or alteration) to:

EXCLUSIONS

Paint or other coatings applied to the Product: The Product does not need painting or staining for protection or to maintain its appearance, although the Product may be painted or stained to achieve a custom color. However, if paint or other coating materials are applied to the Product, by someone other than the manufacturer, this limited warranty will be voided.

Other Exclusions: The limited warranty against manufacturing and material defects in the Product as well as the limited warranty against Product fading contained herein are not applicable to, and the Manufacturer does not warrant against and is not responsible for, and no implied warranty shall be deemed to cover any Product failure, Product malfunction, condition or damage attributable to:

1. Product which was not installed strictly in accordance with the Product's Installation Guide or installed in a less than workmanlike manner
2. Product which has been structurally altered or damaged by fire, flood, lightning, windstorm, hail, hurricane, earthquake, tornado or other acts of God
3. Product which has been installed for or applied to a function or use other than the ordinary purposes for which it was designed and intended
4. Product which has not been properly stored or handled
5. Product which has been damaged during shipment, storage, handling or installation
6. Product which has been damaged by movement, distortion, collapse or settling of the ground or the supporting structure on which the Product is installed
7. Product which has exposure to direct or indirect contact with extreme heat sources (over 250 degrees Fahrenheit) that may damage the surface of the Product
8. Product which has been damaged by accident or ordinary wear and tear
9. Product damaged, distorted, melted due to external heat sources, including but not limited to barbecue grills, fires or reflection from Low-E glass windows, doors or other objects

The Residential Purchaser and the Non-Residential Purchaser are solely responsible for determining the effectiveness, fitness, suitability and safety of the Product in connection with its use in any particular application.
