LIMITED LIFETIME WARRANTY

TROPICAL HARDWOOD COLLECTION

WOLF PVC Decking (Rosewood and Amberwood colors), manufactured by Inteplast Group, Ltd. (IPG), is backed by a lifetime limited warranty for single-family residential purchases and applications. For all other purchases and applications, including commercial use, condominiums and multi-family dwellings, this warranty shall be limited to a period of twenty (20) years. The warranty is limited to the lifetime of the original purchaser for as long as he/she owns the property on which the product is applied and shall not be transferable. If, due solely to manufacturing or material defects, the product is found during this warranty period to rot, delaminate, splinter, crack, split, excessively swell, or suffer structural damage from termites or fungal decay, IPG will, at its sole and absolute discretion, provide replacement product, repair the defective product, or refund a proportional part of the purchase price prorated over 30 years on residential purchases (20 years on commercial and non-residential purchases). In no instance will the cost of the remedy to IPG exceed the original purchase price of the affected product.

CLAIMS

In order to file a valid warranty claim, and before IPG's obligation under this warranty shall commence, the original purchaser must send proof of purchase, photographs of the defective WOLF PVC Decking, and a written description giving full particulars within 30 days of discovering a defect believed to be covered by this warranty (and prior to beginning a repair or alteration) to: Inteplast Group Ltd./World-Pak Division • 9 Peach Tree Hill Rd. • Livingston, NJ 07039 • Attn: CEVN Deck
IPG reserves the right to investigate any claim arising under this warranty. As such, original purchaser shall make available for inspection by IPG or an appointed representative, the product believed to be defective.

EXCLUSIONS

The warranty is limited to the foregoing and shall NOT apply to:

1. product which was not installed in accordance with IPG's installation guidelines or installed in a less than workmanlike manner;
2. product which has been structurally altered or damaged by fire, flood, lightning, windstorm, hurricane, earthquakes, tornado or other acts of God;
3. product which has been put in unusual service, or used for purpose for which it was not designed originally;
4. natural effects under normal weathering of the surface (including fading or discoloring due to exposure to sunlight or weather conditions);
5. cost of labor, materials or the expenses incidental to the repair, removal, installation or replacement of the warranted product;
6. product which has not been properly stored or handled;
7. product which has been damaged during shipment, storage, handling, or installation; or
8. any applications of painting or coating to the Product.

WARRANTY AMENDMENT

This lifetime limited warranty shall not be altered or amended except by a written instrument signed by IPG and the WOLF PVC Deck purchaser. No WOLF PVC Deck dealer or other person or entity is authorized by IPG to make statements about WOLF PVC Decking except those included in this warranty. IPG shall not be liable for statements made by a third party in contravention or in addition to this warranty.

WARRANTY AREA COVERAGE

This warranty shall only be applicable and enforceable in the United States of America and Canada.

DISCLAIMER

THIS WARRANTY IS THE EXCLUSIVE WARRANTY FOR WOLF PVC DECKING. THIS WARRANTY IS IN LIEU OF ANY IMPLIED WARRANTY OF MERCHANTABILITY OR ANY IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. THIS WARRANTY IS IN LIEU OF ANY AND ALL OTHER APPLICABLE WARRANTIES EXPRESS OR IMPLIED. THE REMEDIES, AS SET FORTH IN THIS WARRANTY, ARE THE EXCLUSIVE REMEDIES FOR PRODUCT DEFECTS. IN NO EVENT SHALL IPG BE LIABLE FOR ANY REMOTE, INCIDENTAL, PUNITIVE OR CONSEQUENTIAL DAMAGES OF ANY NATURE (INCLUDING THOSE FROM PERSONAL INJURIES OR PROPERTY DAMAGE), NO MATTER HOW ARISING; NOR SHALL IPG BE LIABLE FOR ANY AMOUNTS IN EXCESS OF THE ORIGINAL PURCHASE PRICE FOR MATERIALS FOUND TO BE DEFECTIVE. Some states do not allow the exclusion or limitation of special, incidental or consequential damages, so the foregoing may not apply to you. This limited warranty gives you specific legal rights, and you may also have other rights which vary from state to state. Building code regulations vary from municipality to municipality and state to state. Therefore, each WOLF PVC Decking purchaser should consult local building and safety codes in order to meet any specific requirements. IPG is not liable for installation of WOLF PVC Decking that fails to meet applicable local building and safety codes.

LIMITED LIFETIME WARRANTY

AVALON SAND & NEW ENGLAND GREY

WOLF PVC Decking (Avalon Sand and New England Grey colors) is warranted by the manufacturer, PCI Building Products, a division of Prime Conduit, Inc. (PCI or "Manufacturer"), in accordance with the terms and conditions set out below, to be free from defects in material and workmanship that (A) occur as a direct result of the manufacturing process, (B) occur under normal use and service, (C) occur during the warranty period and (D) result in blistering, peeling, flaking, cracking, splitting, cupping, rotting or structural defects from termites or fungal decay.

WARRANTY LIMITATIONS

This Lifetime Limited Warranty is void if any of the following occurs: (A) improper installation or failure to abide by the Manufacturer's installation guidelines and local construction codes; (B) comparative discoloration of WOLF PVC Decking due to overlay of a rug, mat or other item precluding uniform exposure of WOLF PVC Decking to sunlight and the elements; (C) movement, settling, distortion or collapse of the ground or supporting structure on which WOLF PVC Decking is installed; (D) naturally occurring casualties including, but not limited to, impact of objects, earthquakes, tornados, hurricanes, lightning, flooding or acts of God; (E) improper handling or storage, neglect or misuse of WOLF PVC Decking either by the Owner or third parties; (F) improper application of paint or other surface chemicals not recommended by the Manufacturer in writing; (G) adverse effects of air pollution; (H) damage resulting from fire or exposure to excessive heat sources such as cooking devices or reflective surfaces, and (I) damage from normal weathering of surfaces.

NOTIFICATION

In order to make a valid claim under this warranty, the contractor/initial purchaser or initial owner of the premises on which the WOLF PVC Decking in question was installed (Owner) must notify PCI in writing, at PCI Building Products, 23240 Chagrin Blvd., Suite 405, Cleveland, OH 44122, within thirty (30) days after discovering the claimed defect and prior to beginning any repair or alteration to the WOLF PVC Decking. The notice must include a detailed description of the claimed defect, a photograph of the defective item and proof of purchase. Further, the Owner must permit PCI Building Products an opportunity to inspect the defect within a reasonable time following receipt of notice of the defect. If, after inspection, PCI Building Products determines that the claim is valid and in compliance with the terms of this Lifetime Limited Warranty, it will repair or replace the defective material, or will refund the original purchase price of the defective material. The choice of remedy is in Manufacturer's sole discretion. PCI Building Products will not be liable for labor and/or material removal costs connected with the claim, if any. Replacement product will be provided with an appearance as close to the original color and texture as reasonably possible. In the event of repair or replacement, the balance of the original warranty shall apply to the repaired or replaced portion of the WOLF PVC Decking.

OTHER CONDITIONS

The Manufacturer does not recommend WOLF PVC Decking for all applications. WOLF PVC Decking is intended for decks, boardwalks and piers. Local construction permitting authorities should be consulted before installation of structures with specific load-bearing capacities and for other zoning and building code requirements. This Lifetime Limited Warranty is valid for single-family, residential applications only. For all other applications, including commercial use, this warranty shall be limited to a period of twenty (20) years.

THE WARRANTY STATEMENTS CONTAINED IN THIS LIFETIME LIMITED WARRANTY SET FORTH THE ONLY WARRANTIES EXTENDED BY PCI AND ARE IN LIEU OF ALL OTHER CONDITIONS AND WARRANTIES, EITHER EXPRESSED OR IMPLIED, INCLUDING WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE PROVISIONS OF THIS WARRANTY SHALL CONSTITUTE THE ENTIRE LIABILITY OF PCI AND THE OWNER'S EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY. IN PARTICULAR, IN NO EVENT SHALL PCI BE LIABLE TO THE OWNER OR ANY THIRD PARTY FOR SPECIAL, INCIDENTAL, INDIRECT, CONSEQUENTIAL, OR PUNITIVE DAMAGES ARISING FROM THE USE OF WOLF PVC DECKING OR THE BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.

WARRANTY REGISTRATION

In order to register your Lifetime Limited Warranty, please register online at www.pcibuildingproducts.com within thirty (30) days of purchase. Failure to do so may void certain portions of this Lifetime Limited Warranty. This Lifetime Limited Warranty and its registration are non-transferable from the Owner to third parties.
